We want to extend a heartfelt thank you for helping us to meet our donation drive in October. We reached our goal of \$1500.




Your Dollars at Work

In addition, we hope to start a compression bursary to help those in the greatest need with the cost of compression.




If you are interested and have the means to donate, the Canada Revenue Agency is extending the 2024 deadline for charitable donations to February 28, 2025.
